The claimant must pay the specified percentage of the list price at the time of the claim for cover replacement. Freight and applicable taxes are extra.

- 0% 1 to 3 Seasons
- 50% 4 to 6 Seasons
- 75% 7 to 12 Seasons
- 80% 13 to 20 Seasons

COMMERCIAL MESH

30- Seasons Warranty with 4-Year Full

- 0% 1 to 4 Seasons
- 50% 5 to 6 Seasons
- 75% 7 to 14 Seasons
- 80% 15 to 30 Seasons

LIGHTWEIGHT SOLID

15- Seasons Warranty with 3-Year Full

- 0% 1 to 3 Seasons
- 50% 4 to 8 Seasons
- 75% 9 to 15 Seasons

SUPREME SOLID

15- Seasons Warranty with 2-Year Full

- 0% 1 to 2 Seasons
- 50% 3 to 6 Seasons
- 75% 7 to 10 Seasons
- 80% 11 to 15 Seasons
